## BOROUGH OF BERGENFIELD Ordinance No. 22-2610

## AN ORDINANCE TO AMEND, SUPPLEMENT, AND REVISE THE CODE OF THE BOROUGH OF BERGENFEILD, CHAPTER 299 ENTITLED "VEHICLES & TRAFFIC"

WHEREAS, Chapter 299 for the Code of the Borough of Bergenfield sets forth regulations regarding Vehicles and Traffic within the Borough of Bergenfield; and,

**BE IT ORDAINED**, by the Mayor and Council of the Borough of Bergenfield, County of Bergen, and State of New Jersey that those portions of the aforesaid set forth below are hereby amended as follows and that those portions of the Ordinance not set forth below shall remain unchanged.

§299-32 Veterans Parking.

A. No person shall park a vehicle on the below street unless that person is a veteran:

Lilac Street 35 feet west of South Washington Avenue for 75 feet

- B. No person shall park a vehicle on the designated areas below unless that person is a veteran and a recipient of a Purple Heart:
  - a. Lilac Street within the vicinity of the designated area from Section (A)
  - b. 8 Veterans Plaza and W Main Street (parallel to rail road tracks, behind DAV Building)
  - c. Municipal parking lots at the following location (within Borough Hall Lot, adjacent to Borough Hall)
  - C. Violations and penalties. Any person convicted of a violation of a provision of this section or any supplement hereto shall be liable to a penalty of \$55.

<u>Severability</u> All provisions of the is Ordinance are severable. If for any reason, any provision of this Ordinance is held to be invalid, the validity of the remainder of the Ordinance shall not be affected.

<u>Effective Date</u> This Ordinance shall become effective upon final approval and publication, pursuant to law, and upon completion of all outstanding cases.
