## AN ORDINANCE AMENDING CHAPTER 299 OF THE CODE OF THE BOROUGH OF BERGENFIELD, ENTITLED "VEHICLES AND TRAFFIC"

# AN ORDINANCE AMENDING CHAPTER 299 OF THE CODE OF THE BOROUGH OF BERGENFIELD, ENTITLED "VEHICLES AND TRAFFIC"

WHEREAS, Chapter 299 of the Code of the Borough of Bergenfield sets forth all regulations regarding Vehicles and Traffic within the Borough of Bergenfield; and,

**BE IT ORDAINED**, by the Mayor and Council of the Borough of Bergenfield, County of Bergen and State of New Jersey that those portions of the aforesaid set forth below are hereby amended as follows and that those portions of the Ordinance not set forth below shall remain unchanged.

#### Section 299-15 - Handicapped Parking

D. Areas covered. The following areas shall be designated as handicapped parking and shall be so marked by signs in conformance with the current Manual on Uniform Traffic Control Devices for streets and highways.
