## BOROUGH OF BERGENFIELD Ordinance No. 17-2520

## AN ORDINANCE AMENDING CHAPTER 95 OF THE CODE OF THE BOROUGH OF BERGENFIELD, ENTITLED "ANIMALS"

**WHEREAS,** Chapter 95 of the Code of the Borough of Bergenfield sets forth all regulations regarding Animals within the Borough of Bergenfield; and,

**BE IT ORDAINED**, by the Mayor and Council of the Borough of Bergenfield, County of Bergen and State of New Jersey that those portions of the aforesaid set forth below are hereby amended as follows and that those portions of the Ordinance not set forth below shall remain unchanged.

<u>Chapter 95 - Animals</u> <u>Ch. 95-8 entitled Regulations.</u>

D. Running at large. No person owning, keeping, harboring, or in charge of any dog shall allow it to run at large upon the public streets, in any public park, in any public building, and/or on any private property within the Borough with the exception of Veterans Memorial Park wherein owners with their dogs may enter between dawn and dusk to access the dog park with their dog leashed at all times while outside the perimeter of the park and until entry into the dog park.

<u>Severability</u> All provisions of this Ordinance are severable. If for any reason, any provision of this Ordinance is held to be invalid, the validity of the remainder of the Ordinance shall not be affected.

<u>Effective Date</u>. This Ordinance shall become effective upon final approval and publication, pursuant to law, and upon completion of all outstanding cases.
