Mayor Amatorio called the meeting to order at 8:05 p.m. with the reading of the Open Public Meetings Act Statement, "In compliance with the Open Public Meetings Act, the notice requirements have been satisfied. Committee/Department Reports

Motion offered by Councilperson Kornbluth that the Committee/Department Reports be spread upon the minutes in full and filed. Second by Councilperson Rivera. All in favor, none opposed.

VERBAL COMMUNICATIONS II

Mayor Amatorio opened the meeting to Verbal Communications II and invited the public to comment on any subject, limited to five minutes per speaker.

Jose Gonzalez, resident, stated that he has a couple of questions with regards to the appointments to boards and committees and inquired the process for becoming a member. Mr. Gonzalez was interested to know how residents can become members of a committee, and inquired if there is an application for appointments. He also inquired if vacancies are announced for people to know how to join. Mr. Gonzalez commented Tenafly, Dumont, Paramus have application forms for people that want to join the board. He expressed this can be a transparent way for residents to be aware of vacancies and the Borough can keep a record of applications.

Mary Hernandez, resident, stated that she has the same questions as Mr. Gonzalez, and inquired what appointments were available and how will the people be selected. She also inquired what were the Council's plans for development in the future, and if part of their plan was to build more apartments in town. Ms. Hernandez also stated that the Traffic Safety Committee meetings should be open to the public at least twice a year.

Mary Sullivan, resident, inquired why minutes have not been posted to the website since October.

Borough Clerk Quinones stated that minutes are posted after their approval at a Regular Public Meeting. The minutes will be posted tomorrow after their approval this evening.

There being no one else who wishes to be heard, Mayor Amatorio closed Verbal Communications II.

Mayor Amatorio stated that with regards to members for the committee, appointments are open to everyone. Residents can communicate their interest with the Mayor and Council. He explained that most appointments are made by the Mayor. Nominations and appointments are made by the Mayor, which are then approved by Council. He explained that the governing body looks for people that want to be part of the team and move forward their agenda. He mentioned that if anyone wants to join, they can share their interests, and will be considered based on qualifications.

Councilperson Kornbluth explained that just because someone is not appointed on a committee, they can be involved from the outside and volunteer their time to be appointed in the future.

Mayor Amatorio stated that the more residents that want to be involved the better. He stated that if someone wants to serve and be involved, the governing body welcomes it.

Council President Marte stated that he received several requests, particularly for the Zoning Board of Adjustment. He commented that all will be considered and the Council will make a decision based on qualifications.

Mayor Amatorio further explained that the positions are never advertised, but residents can reach out and express their interest. He commented that there is a member position and alternate member position available on the Zoning Board of Adjustment. There person may be reappointed, but that is up to the decision of the Council. He further commented that the members of the Traffic Safety Committee are appointed each year. Some members may want to be reappointed, others may not.

Borough Administrator Gallo stated that there is no need to wait for an open Traffic Safety Committee meeting, residents can reach out to him or Police Chief anytime to express their concerns. He reiterated that availability exist, no need to wait to attend a meeting.

Mayor Amatorio stated that if residents have any additional questions, they are welcome to email him or the Borough Administrator.

Jose Gonzalez, resident, requested to speak again. He stated that he did some research, submitted an OPRA request, and learned that no qualifications or criteria are required to serve on the boards. He inquired if the Borough can follow the neighboring towns and have an application available for residents to apply to any available positions.

Council President Marte stated explained that if three residents express interest in serving on the Zoning Board of Adjustment, and one or two of them are architects, engineer, or have a trade of some sort, they have more of the background experience to serve in the position. He commented that their experience is valuable to the board.

Borough Administrator Gallo stated there is no application process to serve on the board. He further stated that he visited the Borough of Tenafly website and is unable to find the application form to serve on boards and committees.

Mayor Amatorio stated that residents should send an email to signify their interest and the governing body will consider them.

COUNCIL COMMENTS

Councilperson Deauna advised everyone to stay safe and wished all a good night.

Councilperson Pascual advised everyone to stay safe and warm, especially during the impending snow storm.

Councilperson Kornbluth advised everyone to stay safe and wished everyone a happy holiday!

Council President Marte expressed that everyone stay safe and enjoy the holidays!

Councilperson Rivera wished everyone a happy Hannukah, happy Kwanzaa, and a very Merry Christmas! He advised everyone to enjoy their time with family and friends, but reminded everyone to keep socially distant and stay safe. Mr. Rivera expressed his blessings to all!

Mayor Amatorio advised everyone to please stay safe during the impending snow storm, and reminded everyone to remove their vehicles from Borough streets and that shoveling snow into the street is prohibited. He stated that the Borough is in the process of finalizing a plan to hold massive testing for COVID-19 in different facilities in town. He wished everyone a happy Hannukah, happy Kwanzaa and a Merry Christmas! He expressed that everyone enjoy the holidays, but please stay safe!
