Mayor Amatorio called the meeting to order at 8:05 p.m. with the reading of the Open Public Meetings Act Statement, "In compliance with the Open Public Meetings Act, the notice requirements have been satisfied. Meeting dates for the year are confirmed at the Annual Meeting. The Annual Notice is sent to the Record, Star Ledger, Twin Boro News, and Cablevision, placed on two Municipal Bulletin Boards and is on file in the Office of the Borough Clerk."

The Salute to the Flag was led by Council President Buddy Deauna.

AGENDA CHANGES

Councilperson Kornbluth requested to add the Bergenfield Public Library's request for street closure on June 26, 2022 from 10:00 a.m. to 5:00 p.m. for their Summer Reading Kick-off event, and a Personnel Action Letter from the Board of Fire Officers to Correspondence. She also added Resolution #22-196 to appoint outside counsel Harriet F. Klein J.S.C. from the firm Wilson, Elser, Moskowitz, Edelman & Dicker LLP, and Resolution #22-197 to hire summer intern Hallie Wikfors to resolutions. On a motion by Council President Deauna, seconded by Councilperson Pascual, and all present voting in favor, the agenda changes were approved.

VERBAL COMMUNICATIONS I

Mayor Amatorio opened the meeting and invited the public for comments on agenda items only, limited to five minutes per speaker.

John Smith, resident, stated that with regards to Ordinance 22-2601 on stormwater management, the ordinance only addresses major construction. He stated that smaller developments are an issue as well. Mr. Smith stated that residents place their gutter pipes under the lawns and into the storm drains. He further stated that on Cameron and Dudley, the water goes onto the street because of the run-off from the new homes.

Councilperson Kornbluth inquired if it is legal to have the water go into the street.

Borough Attorney Schettino stated homes are supposed to have zero run-off, which is the reason they are required to have retention basins and seepage pits.

Mr. Smith also stated that he noticed in the Health Officer's report that people smoke Hookah at Republic 23. He stated that there were issues there this past weekend, and the same is happening at Aloha Krab.

Borough Administrator Gallo stated that the matters will be addressed with the Health Officer. In terms of the ordinance, minor changes had to be made to the verbiage based on the recommendations from the NJDEP.

Public Comments on Ordinance 22-2600.

Jerry Naylis, resident, inquired what criteria was used to determine what properties are in need of redevelopment.

Borough Attorney Schettino explained that it's a process. A planner was hired to complete a study and the Planning Board made recommendations during a hearing to the Mayor and Council. Mr. Schettino stated the criteria is statutory. There are several criteria, but only one criteria is needed to be considered as an area in need of redevelopment.

Mr. Naylis commented that the governing body didn't know what the criteria was.

Borough Attorney Schettino stated that he never said the governing body didn't know what the criteria was. The council relied upon the statute that states it goes to the Planning Board. The

Planning Board makes a recommendation based upon an expert report by a planner. The report is submitted both to the Planning Board and the council.

Mr. Naylis inquired what impact will a change of these particular properties, should there be new or additional housing, have in stormwater, roads, sewers, water supply, traffic, etc. Some additional projects in town are resulting in additional flooding. Mr. Naylis stated once the projects are approved and things are built, it'll be late as we are finding out houses are getting flooded now which weren't before.

Borough Attorney Schettino stated when a project has to be approved, it has to go the Planning Board for site plan approval for ever factor mentioned and is reviewed by the Planning Board so the community can absorb whatever the project is. Mr. Schettino stated Bergenfield would be unique if a few properties would be redeveloped, because there are developments being built in many smaller towns such as Park Ridge, and has not impacted any of the factors mentioned. It has to be presented to the board and the Planning Board has to be satisfied issues don't arise.

VERBAL COMMUNICATIONS II

Mayor Amatorio opened the meeting to Verbal Communications II and invited the public to comment on any subject, limited to five minutes per speaker.

Todd Gelayder, Code Enforcement and Building Inspector, thanked the governing body for his appointment.

Jerry Naylis, resident, inquired what criteria the Mayor and Council relied on in designating the areas for speed humps. Mr. Naylis inquired about how many speeding tickets were issued over the past 3-5 years on the affected streets. Mr. Naylis inquired if the borough looked into the federal guidelines and whether the speed humps should be used to slow down traffic. He stated that the borough did not review the data nor considered how the borough will deal with damage to borough vehicles. He also inquired if residents in the area were notified.

Borough Administrator Gallo stated that he met with the Police Department traffic division and DPW to review the areas because traffic needed to be slowed down due to excessive speeding. He is unsure how many tickets were issued, but the information can be obtained via OPRA. Mr. Gallo stated that these were coordinated efforts between his office, departments, the engineers, and trusts that the proper processes were followed. The signage and striping will be completed this week. Mr. Gallo stated they were bombarded with complaints from residents about traffic, speeding and reckless driving throughout town. The targets areas are streets located by recreation areas and the schools.

Jacqueline Romney, resident, stated that she sent several emails regarding the traffic safety committee, inquiring when the committee meets, where their agendas and minutes are listed, and why the committee is not open to the public. She has sent continuous emails for the information and has not received a response.

John Smith, resident, stated that with regards to the committees to review parking and lighting requirements, he believes the wrong people have been appointed to the committees. He stated that he is unsure what the Police and Fire Department will be able to offer on the matters. He commented that the members of the committees should be comprised of members from the Planning Board, building department, and Zoning Board of Adjustment.

There being no one else who wishes to be heard, Mayor Amatorio closed Verbal Communications II.

Borough Attorney Schettino stated that the ordinance on areas in need of redevelopment did not adopt a redevelopment plan. The ordinance was published properly, but the ordinance title has to be amended to reflect areas in need of redevelopment have been designated.
