Motion offered by Councilperson Deauna that the Committee/Department Reports be spread upon the minutes in full and filed. Councilperson Rivera seconded the motion. All in favor, none opposed.

VERBAL COMMUNICATIONS II

Council President Pascual opened the meeting to Verbal Communications II and invited the public to comment on any subject, limited to five minutes per speaker.

John Perez, resident, thanked the Borough Administrator for his attention to the matter. He stated that the corner of Smith and Clinton is a dangerous intersection. He advised that parking should be prohibited from 100 feet to the corner. He inquired the status of the Borough fixing the curbs and whether parking will be permitted on both sides of the street.

Borough Administrator Gallo stated that he knows the street needs to be repaved. When its scheduled, it'll have all the infrastructure work done and the road may be widened. The Borough is working on putting the curbs in.

Barry Doll, resident, stated that he understands the CRC approved Eleven's application. He inquired what are the next steps.

John Smith, resident, stated that the Sunshine Adult Day Care Center parks their vans all along the front of the facility and in the bus stop, which impacts the traffic flow. He commented that the buses are unable to pull into the curb and have to pick-up and drop-off passengers in the middle of the road. The drivers are also unable to turn on the intersection. In the past, former Police Chief Madalone addressed the matter and it was temporarily resolved. He stated that recently, borough employees and code enforcement officials drove past the vans and never addressed it. Mr. Smith stated this is an on-going issue with traffic on Washington Avenue and someone needs to look into it and the drivers need to be ticketed.

Mary Sullivan, resident, stated she too has had a problem with the Sunshine Adult Day Care Center vans being parked at the bus stop. She commented that the traffic goes around the bus, which is a problem.

Sergeant Major Williams, resident, stated that wood in the railroad crossing on Main is going bad. He stated that if this is not fixed, it can lead to a bad accident. He also stated that since the Pizza Hut on S. Washington has no parking, people are double parked all the time, day and night.

There being no one else who wishes to be heard, Council President Pascual closed Verbal Communications II.

Borough Administrator Gallo stated that with regards to the railroad crossing, he and the Police Department have notified CSX. He will ask the Police Department to follow up as it a hazardous situation and it needs to be fixed. He further stated that he will speak to Police Chief Rabboh about Sunshine Adult Day Care Center and the stores on the avenue. Mr. Gallo stated that with regards to the license and its approval, the Borough hasn't been notified. He commented that the State has not provided the borough any formal notification with regards to the approval. If it was approved, there are state regulations the business will have to meet. Then, the business owner will need to submit applications to the boards because the interior and exterior of the facility have to be retrofitted, and they have to meet all the standards. The application will probably have to go to the Planning Board, Site Plan, and possibly even Zoning. He commented that they may have received approval from the State, but this is all a process.

The Councilmembers thanked everyone for coming to the meeting and wished all a good night.
