OFFICIAL MINUTES BOROUGH OF BERGENFIELD MAYOR & COUNCIL REGULAR MEETING MAY 16, 2023

Mayor Amatorio called the meeting to order at 8:05 p.m. with the reading of the Open Public Meetings Act Statement, "In compliance with the Open Public Meetings Act, the notice requirements have been satisfied. Meeting dates for the year are confirmed at the Annual Meeting. The Annual Notice is sent to the Record, Star Ledger, Twin Boro News, and Cablevision, placed on two Municipal Bulletin Boards and is on file in the Office of the Borough Clerk. Notice of this meeting dated Friday, May 12, 2023 was published in the Record and sent to the Star Ledger, Twin Boro News, and Cablevision, placed on two Municipal Bulletin Boards and is on file in the Office of the Borough Clerk."

The Salute to the Flag was led by Councilperson Almonte.

AGENDA CHANGES

Borough Clerk Quiñones-Wilson stated that Resolution #23-179 awarding the bid and approving their contract to Halecon, Inc. for the Thomas Roos Park Improvement Project, including the Tennis Court Resurfacing and Pickleball Court Installation should be added to the consent agenda.

Councilperson Lodato motioned to add the Resolution #23-179 to the Consent Agenda. Councilperson Deauna seconded the motion. All present voting in favor, none opposed.

APPROVAL OF MINUTES

Motion by Councilperson Deauna to approve minutes of the April 18, 2023 Regular Public Meeting and April 18, 2023 Closed Session Meeting (not to be released), May 2, 2023 Work Session Meeting and May 2, 2023 Closed Session Meeting (not to be released). Councilperson Rivera seconded the motion. All present voting in favor, none opposed.

VERBAL COMMUNICATIONS I

Mayor Amatorio opened the meeting and invited the public for comments on agenda items only, limited to five minutes per speaker.

John Smith, resident, stated with regards to storm water management, he referenced N.J.A.C. 7:8 for major developments in regards to storm water development. He stated that although there are no major developments going on in the Borough at the moment, there are a lot of non-major developments, which is increasing stress on the storm water management system. He stated that home construction projects are causing problems. He mentioned that there are houses that have gutters running straight to the road and not running into areas where it can be soaked up. The Zoning Board of Adjustment deals with different variances for side yards or lot coverage, which not all require a seepage pit. He stated there is nothing in the ordinance that requires smaller projects to have seepage pits.

Borough Administrator Gallo stated that this ordinance pertains lot coverage because if the addition exceeds lot coverage, it will need a seepage pit. This ordinance was previously tabled and is up for discussion, and he will take the information under advisement. There are many moving pieces and opinions on how this should be done and that is why it is up for discussion tonight. Under the current format for example, if a resident chooses to add an addition to their driveway with no issues to lot coverage, they would be required to add a seepage pit.

Mayor Amatorio stated that based on the proposed arguments, there would be a need for a seepage pit if the addition exceeds lot coverage. He suggested that the discussion to be continued and the matter be tabled.

There being no one else who wishes to be heard, Mayor Amatorio closed Verbal Communications I.

PRESENTATIONS

A. Proclamation in honor of the Department of Public Works

Mayor Amatorio stated that he extends his appreciation to the DPW for all their hard work helping with Borough operations, as well as all the residents when they are in need. The DPW has improved the quality of life for the residents by the hard work that they do. The DPW is a big part of Bergenfield and he cannot thank you enough for the work you do every day.

John Smith, resident, inquired if the \$60,000 received from the County is for Veterans Memorial Park.

Borough Administrator Gallo stated that the grant application is for a matching grant for Clover Park. This is a different application.

Sergeant Major Williams inquired if the grant funding will be used for the renovations at Veterans Memorial Park or spread throughout the park.

Mr. Gallo stated he is unsure the funding he is referring to, but will look into tomorrow. The funding referenced in this particular resolution is for Clover Park.

Mayor Amatorio stated this grant is for the renovations to Clover Park tennis courts.

Barry Doll, resident, stated that the application references the preservation of farmland and historic preservation trust fund.

Mr. Gallo clarified that is how the County names the program for the grant funding, that is not the Borough's title.

Marisa Lonardo-Xu, resident, inquired if the private tennis club is still around.

Mr. Gallo stated that the private club is in operation under a different owner. It still exists. The borough used to lease the facility to Adheek Tennis Club, but now someone else leases and maintains the property.

VERBAL COMMUNICATIONS II

Mayor Amatorio opened the meeting to Verbal Communications II and invited the public to comment on any subject, limited to five minutes per speaker.

John Smith, resident, shared pictures with the governing body and asked for citation or award to the Bergen County Sheriff's Department for building a wheelchair accessible ramp to help a Veteran from Hawthorne. The program employes prisoners to build accessible playgrounds and ramps through a prison release program. He asked on behalf of the Veteran's Committee for the Mayor and Council to issue an award the Sheriff's Department and the Officer who oversaw the project which was completed in a day and a half. All the Veteran had to do was provide food to the workers. He also mentioned the meeting that went on between the Veterans Committee and the Administration in reference to the Memorial Day Parade and the planning for that continues.

Sergeant Major Williams, resident, explained the situation of the Veteran from Hawthorne and how they worked to get not only the ramp, but enrolled him for his Veteran's health benefits. He announced that the Post would hold enrollment and information sessions on Wednesdays. He also wanted to extend his and the Veterans Committee appreciation to the DPW for an outstanding job.

Marisa Lonardo-Xu, resident, stated she emailed the Borough Administrator about the Pride Event in town. She asked when the Pride event will take place, saying there was nothing on the calendar, as Bergenfield drags their feet on the event. She continued to state that Bergenfield is the only town that puts the date out late. There is no notice and the hope is that the date can be put on the calendar sooner.

Borough Administrator Gallo responded that the Stigma Free Committee coordinates the events and shares the information with the borough.

Mayor Amatorio stated that last year we had a great event at Cooper's Pond. The Stigma Free held a flag raising and a public speaking event, and may be planning other events this year. These events will happen all year round, not just in June and are run by the Stigma Free Committee.

Barry Doll, resident, stated that the Mayor and Council should update the process for appealing the decisions of the Zoning Board of Adjustment. He mentioned that in Old Tappan, the Mayor and Council handle the appeal process for the Zoning Board of Adjustment and the Planning Board. Mr. Doll requested that the Mayor and Council adopt a similar process and he volunteered to do the research on how other towns do this as a private citizen. The average person should be able to come to the Mayor and Council and ask for an appeal and reverse of a zoning board approval, it is currently not due process in his view.

Councilperson Lodato stated Bergenfield used to have a similar statue, but the Borough repealed that section under Mayor Bohan.

Borough Administrator Gallo that with regards to the pride event, the date for the flag raising is on the event calendar on the Borough newsletter, which was delivered to every household in the borough. The information will be updated on the website and advertised closer to the event date. He also stated that all the information received from the County regarding the Veteran's events are posted through all borough channels to ensure all residents are informed.

There being no one else who wishes to be heard, Mayor Amatorio closed Verbal Communications II.

COUNCIL COMMENTS

Mayor Amatorio extended his sincere congratulations to John Smith for his award and recognition by the Bergen County Veteran's Services this past Friday.
