# ORDINANCE 23-2612 – AN ORDINANCE AMENDING CHAPTER 268 OF THE CODE OF THE BOROUGH OF BERGENFIELD, ENTITLED "STORMWATER MANAGEMENT" (RE-INTRODUCED 8/8/23)

Councilperson Kornbluth stated that the Planning Board made recommendations based on state requirements. She stated that she would like to incorporate their recommendations into the ordinance.

He explained that an ordinance as such may not need violations, because if the applicant isn't compliant, then the permits should not be issued. If the permits are issued and the person fails to comply, then the permits should be rescinded.

Motion by Councilperson Kornbluth that Ordinance 23-2612 be amended to include the Planning Board recommendations, be re-introduced and passed on first reading and setting October 3, 2023 at 8:00 p.m. or as soon thereafter as the matter can be heard as the date and time and the Bergenfield Public Library as the place for a hearing on said ordinance. Committee/Department Reports

Motion offered by Council President Pascual that the Committee/Department Reports be spread upon the minutes in full and filed. Councilperson Deauna seconded the motion. All present, voting in favor, none opposed.

# VERBAL COMMUNICATIONS II

Mayor Amatorio opened the meeting to Verbal Communications II and invited the public to comment on any subject, limited to five minutes per speaker.

Fred Sahlberg, resident, stated that two ambulances are being serviced and parked on the same side of the tracks that the Ambulance Corps building is located. He asked how do you serve the other side of the tracks. Mr. Sahlberg also asked about the procedure of how and which flags are flown at Borough Hall and why is the flag at half-staff.

Diana Flagg, resident, stated her confusion on changing Lincoln's Birthday as a holiday to July 5<sup>th</sup> and if it was going to be a permanent change. She inquired if the additional changes for the Juneteenth holiday is in the updated contract and how will this affect next year's contract.

Mary Sullivan, resident, stated she saw a vaccine clinic that was being sponsored by the Borough Hall at Conlon Hall. She asked which vaccines will be offered and if it is being published. She also asked how the Ambulances can be parked tandem. She stated that if one ambulance does not start, it can create an issue for the one parked behind it.

Barry Doll, resident, stated that litigation matters are listed under closed session, but there is no specific information like the number of cases. He also stated that 200 apartments on Washington Avenue is overdevelopment, and this is not that type of town. People came here for a suburban atmosphere moving away from cities. The Council is helping the developers, not the town. Two hundred apartments will bring more people and that will change this town. He asked about how this will affect the existing infrastructure.

John Smith, resident, stated that Schedule B needs to be updated with changes made. Mr. Smith stated under provisions, item B should be the Zoning Board not the Borough Engineer. He stated under item E, the seepage pit should be inspected every year, inquired who will do this yearly inspection, and how is this paid for once the escrow has been used. He stated in item F, all sump pumps and roof draining must go to the seepage pit, but who will enforce this and who is responsible for inspections and enforcement of the changes. The Planning Board approved the plan, but where are their recommendations. It's not in the Planning Board minutes. He inquired why there is a patrol car parked by the Synagogue. Mr. Smith stated there are vehicles parked on both sides of Prospect Avenue.

There being no one else who wishes to be heard, Mayor Amatorio closed Verbal Communications II.

Borough Administrator Gallo stated there is a total of five ambulances. They are parked closer to where the operators and the members who drive them are. It is a closer run, with BVAC still covering, but you have additional coverage. The tandem parking will be looked into. Mr. Gallo stated the police car parked was in response to a request for coverage for the Jewish holiday. BVAC's response times have been quicker now that the two ambulances are parked closer to where the operators live. Mr. Gallo explained there have been no complaints about the response times for the ambulances. He stated that as part of the collective bargaining with the various unions excluding the police department, if all the unions agree by a certain date to make a change, they are allowed to by council approval. We do not know what will happen next year, but if a change is to take place. it will follow the same process. There are no additional days added by this change. Mr. Gallo stated Juneteenth is a federal holiday, offices are closed either Friday or Monday. He deferred to the borough attorney regarding litigations. There are a couple of personnel litigations that he needs to update the council on the status. They are all in different processes of litigation, but are covered by JIF. The stormwater management questions will be looked into once the ordinance is revised with the changes recommended. Mr. Gallo stated in reference to the flags, the borough follows the state and federal requests. There is a schedule for changing flags because it requires the bucket truck. This will be fixed with the new building, because it won't require the additional resources. He stated better process is needed on how the flags are scheduled and he welcomes any insight.

#### COUNCIL COMMENTS

Councilperson Lodato stated he is opposed to the building being four stories, not development. His position has not changed.

Councilperson Deauna thanked all for coming and to have a good night.

Councilperson Kornbluth thanked all for coming and to have a good night.

Councilperson Rivera inquired how many stories is the building across from Roy W. Brown Middle School and inquired how long has it been there. He thanked all for coming and to have a good night.
