# **SWEARING-IN OF COUNCILMEMBERS**

Bergen County Clerk John Hogan stated it seems like the world is upside down, the world needs to turn to their elected officials to know it will be ok. On November 7<sup>th</sup> 2023 in Bergen County, we had fair, open and honest elections with definitive results. He stated in Bergenfield the turnout was 31percent, which was higher than the county turn out percentage.

Bergen County Clerk John Hogan read the Election Certificate of Mayor-Elect Amatorio. Mayor-Elect Amatorio received 4,255 votes.

#### **PRESENTATIONS**

Assemblyman Chris Tully stated this meeting was his sixteenth reorganization in Bergenfield. He stated it is great to see how far Bergenfield has progressed with the new building, parks, and roads. The Mayor and Council have done a great job and it is a pleasure to attend and celebrate the new council.

Assemblywoman Lisa Swain stated she was so impressed with the turn out tonight. She explained that Bergenfield is a diverse and inclusive community and expressed her pride that Bergenfield is part of the 38th district.

Senator Joe Lagana thanked the Mayor for the ability to swear him in. He stated Bergenfield is a great town, the town benefits from great representation and it shows with the support in the audience. Senator Lagana stated it is a pleasure to represent Bergenfield in Trenton.

County Commissioner Tom Sullivan stated it's an honor to be in Bergenfield. It has always been a diverse community and that we should embrace that diversity as it changes. Commissioner Sullivan presented Mayor Amatorio with a certificate of commendation from the Commissioner's office.

County Commissioner Germaine Ortiz praised the culture and diversity of the community and how it is represented by the council. She also praised the family members of the elected officials as they sacrifice time too. Commissioner Ortiz presented Councilman Pascual with a certificate of commendation from the Commissioner's office.

County Commissioner Rafael Marte congratulated everyone in attendance. As a former Bergenfield Councilman, he has the honor to stand up next to Councilman Almonte. Commissioner Marte presented Councilman Almonte with a certificate of commendation from the Commissioner's office.

Mayor Amatorio introduced and welcomed First Lady of New Jersey Tammy Snyder Murphy and read her biography into the record.

Tammy Murphy thanked the Mayor for the introduction. She stated it was an honor to be in attendance and a pleasure to be in Bergenfield. She praised the steady leadership in Bergenfield, doing an incredible job, especially during the challenging hard times going on around the world. She praised Mayor Amatorio's inspiring story as a child of public-school teachers and his American Dream as an immigrant. She stated that same story is reflected by Council Members Pascual and Almonte, also immigrants who have a commitment to public service.

Mayor Amatorio presented the first lady with a key to Bergenfield, a book on the History of Bergenfield, and a Granted Coin with the seal of Bergenfield.

Bergen County Sheriff Anthony Cureton commended the great work of the current governing body. The Sheriff also acknowledge the great work done by Bergenfield Police Chief Mustafa Rabboh as a partner. He also presented the Mayor and Council Members with a proclamation from his office.

#### STATEMENTS AND INTRODUCTIONS BY MEMBERS OF THE GOVERNING BODY

Councilperson Lodato thanked Tammy Murphy for attending and also thanked everyone in the audience for coming to the meeting. He also congratulated Mayor Amatorio, Councilman Pascual and Councilman Almonte for their victory and looked forward to working with them this year. He also extended his appreciation to the Borough Administrator for the hard work it took to hold the first meeting in the new Borough Hall.

Councilperson Deauna congratulated the Mayor and Councilmembers for their victories. He stated for two successive elections, the members have run unopposed because the governing body possesses the unique ability to govern by honoring its pledges and preform its duty with dignity and honor. Councilman Deauna stated he is proud to be part of this team, who does not sit on their laurels or let complacency rule. This new Borough Hall is just one example that we do good things to make our residents proud. We all thank you for trusting us and we will always strive to maintain that trust.

Councilperson Almonte expressed his gratitude and honor for the support of the town. Councilman thanked God, his wife, and children for their support. He continued to thank all of the dignitaries in attendance for attending and is looking to move forward. He also thanked the Mayor and Council for the support as he enters his first term in office. Finally, he thanked the residents for their support, entrusting him as he governs.

Councilperson Kornbluth stated Bergenfield is a model inclusive community. She thanked all the dignitaries for coming and for the support they always provide to the borough. She expressed her pride of being a member of the council. She stated, while they do not always agree, all of her colleagues work together and respect each other.

Councilperson Rivera stated it has taken a long time from the initial planning of the building in 2017 to holding the first council meeting of 2024 in the new building. He stated under the leadership of the Mayor, Council, and Borough Administrator, they are able to have this new beautiful building. He congratulated his colleagues, their wives and children, especially Councilman Almonte, who first helped him get elected.

Councilperson Pascual stated the families of the council members are the shoulders they lean on. The councilman thanked the Commissioners, Chairman, NJ State Legislatures, for attending the ceremony. He stated the opportunity to be a councilman was special and was glad to accept it with grace.

Mayor Amatorio presented his state of the Borough speech after thanking the residents, family, and friends for supporting the entire team. He thanked Senator Lagana for swearing him in for the fourth time and second time as Mayor. He thanked first lady and governor for attending and their support, the county commissioners and sheriff, as well as Mayor Fulop, Mayor Tomasco, former Mayors Rivas and Gallione, and Father Sean of St. John the Evangelist Church. Mayor Amatorio thanked his wife and children for their support and inspiration, his team on the council and the borough staff, board members and volunteers. He reflected on the success of the four key agenda items in his first term, infrastructure upgrade, economic development, finance stabilization, and investments in upgrades in recreation facilities. The Mayor stated, in the next term, his key focus will be rejuvenating areas of redevelopment, affordable housing for seniors, upgrade to Cooper's Pond, road repairs, triple A credit rating, a commitment to fiscal responsibility, enhanced recreation around Vivyen Field, addressing flooding issues, and environmental sustainability.

Carol Zapotos, resident, stated unoccupied store fronts have posters advertising events outside of Bergenfield. Flags that were put out for the Memorial Day celebration have not been kept up and are not treated with respect. She has found flags in borough flower pots, and believes both will bring down the aesthetics of the town. Ms. Zapotos presented flags and posters to show the Mayor and Council.
