VERBAL COMMUNICATIONS II

Mayor Amatorio opened the meeting to Verbal Communications II and invited the public to comment on any subject, limited to five minutes per speaker.

Neil Williamson, resident, stated that he would like to open a retail cannabis business in Bergenfield. He stated that he and his colleagues have a proposal that covers all safety and inclusionary issues. He stated that Isaiah's Basement is a way to offer a tax revenue in a safe environment. He would like to meet with the governing body to share his ideas.

Borough Administrator Gallo stated that no retail cannabis is permitted in the borough.

Diana Flagg, resident, inquired the status of the plantation. She commented that a couple of months ago, the council voted to give DPW the day after July 4th off, instead of Lincoln's birthday. She further commented that many people in town have barbecues on July 4th, and inquired whether there will be an extra pick-up in July. She questioned if there will be an additional pick up on Saturday. She stated that the dates are not on the calendar. Ms. Flagg asked if there will be an additional pick-up as the Jewish community receives during their holidays. She also expressed that Washington Avenue is a nightmare with people making U-turns and the handicapped parking spots are limited and those spots are filled with cars without placards. She also stated that there are limited handicapped spots on the avenue.

Mary Sullivan, resident, inquired whether the drive-up mailbox will remain near borough hall after the construction of the new building and demolition of the old borough hall. She expressed her concern because many residents utilize the drive-up box.

There being no one else who wishes to be heard, Mayor Amatorio closed Verbal Communications II.

Borough Administrator Gallo stated that upon review of the tonnage report, the DPW tried to work through the holidays, because more than half the time, some areas only need pick-up once a week.

The change in the schedule was due to negotiations with the unions that represent workers at the borough. Mr. Gallo stated that if the amended schedule doesn't work, it will be reconsidered next year. He stated that there isn't an additional pick-up, a dump truck is left at Memorial Park for the residents.

COUNCIL COMMENTS

Council President Rivera clarified there is no plantation in the borough.

The governing body thanked everyone for attending the meeting and wished all a good night.
