Mayor Amatorio called the meeting to order at 7:15 p.m. with the reading of the Open Public Meetings Act Statement, "In compliance with the Open Public Meetings Act, the notice requirements have been satisfied. Meeting dates for the year are confirmed at the Annual Meeting. The Annual Notice is sent to the Record, Star Ledger, Twin Boro News, and Cablevision, placed on two Municipal Bulletin Boards and is on file in the Office of the Borough Clerk."

The Salute to the Flag was led by Councilperson Deauna.

AGENDA CHANGES

Councilperson Pascual motioned to add Resolutions #21-394 to approve T&M Associates' proposal to conduct a preliminary analysis within Metzler's Brook, #21-395 to approve Neglia Engineering's proposal for planning services for areas in need of redevelopment, and #21-396 requesting the Planning Board's review of additional areas in need of redevelopment to the consent agenda. Councilperson Deauna seconded the motion. All present voting in favor, none opposed.

VERBAL COMMUNICATIONS I

Mayor Amatorio opened the meeting and invited the public for comments on agenda items only, limited to five minutes per speaker.

John Smith, resident, inquired with regards to a Medicare reimbursement on pages 2 and 17. He inquired why the same person is being refunded twice. He questioned the policy and why it's taken several years for the person to be refunded.

Borough Administrator Gallo stated that the received date and the date the purchase order was prepared differ. He will verify the reason, but he has a series of bills going back a number of years that needed to be paid. He signed off on them and remembered seeing the statements.

Rich Cahill, Borough CFO, explained there are employees that retired from the borough with a set number of years of service with full benefits. As part of that benefit, they are entitled to reimbursement of Medicare part B. The refunds are being taken from two separate budgets for different amounts.

Borough Attorney Schettino stated that the purchase order can be pulled and the bill list can be approved subject to verification.

ORDINANCE 21-2589 - AN ORDINANCE AMENDING CHAPTER 232 OF THE CODE OF THE BOROUGH OF BERGENFIELD, ENTITLED "PROPERTY MAINTENANCE"

Public comments on Ordinance 21-2589.

Mary Sullivan, resident, requested an explanation on the ordinance.

Borough Administrator Gallo explained that changes need to be made to the borough code to update the code from the 2003 edition of the International Property Maintenance Code to the 2021 edition. He explained the packet is too thick to be disseminated, but will be available in the borough code.

John Smith, resident, inquired who will enforce the code. He stated that code enforcement is not enforcing the code or issuing summonses. He further stated that the code enforcer is being compensated \$80,000 per year, but is not enforcing the code.

Mayor Amatorio stated that he understands the concern on enforcement, but the borough code has to be updated.

Motion by Councilperson Deauna, seconded by Councilperson Pascual to pass Ordinance 21-2589 on second and final reading and are hereby adopted and notice of same shall be published according to law as amended.

VERBAL COMMUNICATIONS II

Mayor Amatorio opened the meeting to Verbal Communications II and invited the public to comment on any subject, limited to five minutes per speaker.

Mary Sullivan, resident, demonstrated a Huntington Learning Center sign that has been left at the Public Library's parking lot and borough right of ways. She stated that the learning center should be fined. She further stated that the 2022 recycling calendar advertised on the borough website has many errors. Ms. Sullivan stated there are yellow squares on the calendar, but she is unsure what they mean because there is no color key or explanation of the codes. Ms. Sullivan also stated that the Fire Department lights parade was not advertised on the borough website. She never received a robo call, nor was it advertised on the Fire Department website.

Mayor Amatorio stated the signs will be picked up tomorrow. Huntington Learning Center will be notified and given a warning. The Fire Department lights parade was on social media.

Borough Administrator Gallo stated the printed recycling calendar has the answer key. He will update the calendar on the website with the correct version.

Barry Doll, resident, referenced the information available on the website for the proposed building, and stated that in review of the debt service, the cost of the building with the bond and construction, is going to cost the borough \$45 million. He noted an article in the Jewish Link regarding a \$100,000 contribution made by residents for the purchase of BVAC equipment. He commented that there was a need and the residents responded. He stated that residents would like a definitive figure for the new building.

John Smith, resident, stated that the Veterans Advisory Committee submitted a request to their liaison for members to be added by resolution, but the item never made it onto the agenda. Mr. Smith stated that the committee would like a liaison that can attend the meetings and relay information to the Mayor and Council.

There being no one else who wishes to be heard, Mayor Amatorio closed Verbal Communications II.

COUNCIL COMMENTS

Councilperson Lodato thanked everyone for coming to the meeting and wished everyone happy holidays and happy new year.

Councilperson Deauna wished everyone a Merry Christmas, and advised everyone to please get tested for COVID-19.

Councilperson Pascual advised everyone to be safe and practice social distancing. He wished everyone happy holidays.

Borough Administrator Gallo stated that the information referenced in the Jewish Link was shared with him and members of the governing body during the volunteer dinner. He explained that there is a situation with a private ambulance corp. coming into town, and as such, the BVAC was proactive and went to a few people for donations to purchase the equipment they need. He noted that the Mayor and Council has always been supportive and has purchased all the items the ambulance corp. has asked for. He further stated that in reference to the reimbursement payments, there were two purchase orders because one is for calendar year 2019 and the other is from calendar year 2020. The person submitted for reimbursement for payments made towards their Medicare. He stated that the person may have been sick, lived out of state, or perhaps dealing with other circumstances.

Mayor Amatorio stated that every year, departments are asked for a list of items they need. The Mayor and Council has always been supportive to meet those needs. He thanked everyone for coming to the meeting and wished all a happy and healthy holiday season.
