AN ORDINANCE TO AMEND, SUPPLEMENT AND REVISE SCHEDULE "B" OF THE CODE OF THE BOROUGH OF BERGENFIELD, CHAPTER 186 ENTITLED "ZONING"

BE IT ORDAINED by the Borough Council of the Borough of Bergenfield, County of Bergen, State of New Jersey, that the following amendments and revisions are made to the Revised General Ordinances of the Borough Bergenfield, Chapter 186 entitled "Land Development Ordinance of the Borough of Bergenfield, New Jersey".

Section 1

ARTICLE IV, Zoning Regulations and Establishment of Zones, Schedule "B" is amended in the following particulars only:

- a. The column entitled "Zone District" is amended as indicated below:
 - R-M Multifamily zone shall be retitled as R-M Garden Apartment.
 - R-S Senior Citizens shall be retitled as Senior Citizen Apartment.
 - B-1 zone shall be retitled as B-1 Retail Business.
 - B-2 zone shall be retitled as B-2 Business and Professional.
 - M zone shall be retitled as M Light Industrial and Automotive.
 - P zone shall be retitled as P Parks and Public Purpose.
- b. Building Height (feet/stories) column shall be amended as indicated below:
 - R-40 shall be 30/2
 - R-15 shall be 30/2
 - R-6 shall be 30/2
 - R-5 shall be 30/2
 - R-M Garden Apartment

Multifamily dwellings other than townhouses 40/3

Townhouses 35/2

- B-1 Zone shall be 40/3
- B-2 Zone shall be 40/3
- c. Notes: shall be amended as indicated below:
 - 2. Existing language shall be deleted and replaced with "Corner lots in the R-5 zone require fifteen-foot front yard on side street".
